ORDER AND JUDGMENT*

Before BACHARACH, SEYMOUR, and McHUGH, Circuit Judges.

On September 7, 2018, defendant Alan J. Haag was convicted of a single count of possession of a firearm by a prohibited person pursuant to 18 U.S.C. §922(g)(1). Judgment entered on November 28, 2018, and this appeal followed. On July 23, 2019 the parties filed a *Joint Motion for Summary Disposition*. In the *Motion*, the parties request that we vacate Mr. Haag's conviction in light of *Rehaif v. United States*, 139 S. Ct. 2191 (2019), and that we direct a remand so that the United States may dismiss

Mr. Haag's 18 U.S.C. §922(g)(1) charge. Upon consideration, the *Motion* is granted as modified in this Order and Judgment.

We grant the parties' request to dispose of this appeal by summary disposition in light of the *Rehaif* decision. We remand, however, with instructions for the district court to vacate the conviction and to allow the United States to dismiss the underlying charge.

The Clerk is directed to issue the mandate forthwith.
