Counsel:

The 10th Circuit's appellate CJA attorney panel is administered under the court's Criminal Justice Act Plan, Addendum I to the local rules and can be reviewed at <http://www.ca10.uscourts.gov>. The court's general presumption is that trial counsel will continue for the appeal, but the Plan and the appellate panel now provide a strong pool of qualified lawyers to take appeals, which, for a variety of reasons, require the appointment of new counsel. The court appoints substitute appellate counsel from its CJA panel and the Federal Public Defender's office.

New applications for the panel must be submitted not later than February 1, 2014 to CJA_Vouchers@ca10.uscourts.gov with a pdf copy of your current resume/c.v. and an appellate writing sample. The court's CJA Standing Committee will review all materials submitted, contact references, and meet later in the spring to consider recommendations to the Judges of the court.
